ORDER

In terms of instructions issued by Department of Public Enterprises vide OM No.11/36/97-Fin dated 9th October, 1997, as amended from time to time, the approval of competent authority is hereby conveyed for grant of Category – 1 Miniratna status to the Airports Authority of India, a public sector undertaking under the Ministry of Civil Aviation, subject to the following conditions:-

- (i) AAI will not be provided with any budgetary support henceforth except for implementing Government sponsored projects of national interest approved by the competent authority.
- (ii) The project shall be deemed to be of national interest when the project approving authority declares it so at the time of according its approval
- (iii) The investment decision in respect of such projects with Government support would be taken by competent authority in Government through EFC/PIB/CCEA route.

2. Consequent upon grant of Category – 1 Miniratna status, AAI is eligible to exercise enhanced autonomy, financial power etc as per instructions issued by Central Government from time to time.
