Sub : Coverage under EPF & MP Act 1952 – extension of date by 22.05.2008

Reference is invited to letters No.AAI/CPF/Pension Scheme/2007 dated 03.10.2007 and 17.10.2007 wherein the employees were required to exercise their option on or before 19.11.2007 in Annexure-II as per letter dated 03.10.2007 (the option form is available on website of AAI (i.e. <http://infosaarthee>).

2. It is observed that some of the employees have not exercised the option as required under the Employees Pension Scheme. It is reiterated that in the event of non-receipt of any option from the employees, the recovery towards the Pension Scheme will be made on the basis of ceiling applicable as indicated in letter dated 03.10.2007. It is mentioned that there is no provision in the Act / Scheme to change or submit the option at a later stage.
3. In view of the above, the last date for submission of the options by the employees is extended and the employees are requested to submit the option so as to reach at CHQ / RHQ / Metro Airports **on or before 22.05.2008**. Option form is available on above mentioned website as Annexure-II of letter dated 03.10.2007. A copy of the option form is also enclosed for ready reference.
4. It is mentioned that this is a **final opportunity to exercise the option** and in absence of any option, without making any further reference, the recovery of pension contribution will be made as per ceiling applicable under the Pension Scheme and also Pensionary benefits will be available as per the ceiling applicable at the time of entitlement of benefits.
