OFFICE ORDER

In pursuance of CHQ letter no. A-60011/23/2005/P&C/1446(RTI) dated 23.04.2010 (Copy enclosed) Shri Anil Kumar, General Manager(CNS), Mumbai is appointed as PIO, RHQ offices, WR, AAI for the matters pertaining to RTI Act 2005. (Ref para -c)

2. All Airport Directors/ Airport Controller/Station In-charges shall function as the PIOs in respect of their respective airports. (Ref para-c)

3. The RED,WR will function as the Appellate Authority under the RTI Act not only in respect of his own respective offices but also the other Airports/Units under his jurisdiction. (Ref para -f)

4. RED,WR will also be the Nodal Officer for the matters falling within his jurisdiction. The Nodal Officer will be responsible for co-ordination work of various PIO's in the respective region/airports & will also settle any dispute concerning any point of the RTI application or issue under RTI Act. (Ref para-h)

5. Since RTI work is also a part of one's duties/responsibilities, in the absence of the nominated PIO/Appellate Authority on account of any reason, the officer looking after his work will automatically function as the PIO/Appellate Authority in respect of those RTI matters till the nominated PIO/Appellate Authority resumes his/her duties. (Ref para-g).

6. The detailed instructions contained in the above mentioned CHQ letter may be strictly adhered to.

7. Contents of the CHQ letter may be given wide publicity.

8. The above will be effective from 01.06.2010.
