
CIRCULAR

Sub : Implementation of Integrity Pact in AAI- Revision of Threshold Limits.

1. In order to bring more procurements under the Integrity Pact (IP) competent authority has decided to reduce the threshold limits for the applicability of IP earlier fixed vide circular AAI/PMQA 7001/2013 dated 27th May, 2013.
2. The revised financial limits are as under:-

Sl.no.	Contracts	Threshold Values
(i)	Civil/Electrical/Composite Works	Rs. 5.00 Cr. & above
(ii)	CNS/Electronics/Tech./IT Works	Rs. 2.50 Cr. & above
(iii)	Land/Commercial contracts	Rs. 2.50 Cr. & above
(iv)	Procurement of Stores such as Uniform, Housekeeping items, Stationary etc.	Rs. 1.00 Cr. & above
(v)	Project on BOO basis (New DOP approved by AAI Board on 27 th Dec. 2012	Rs. 1.00 Cr. & above

3. It is mandatory to incorporate IP provision in all contracts as per the limits above. Apart from that the NIT approving authorities may decide at their discretion whether IP is to be applied for any other contract as per SOP clause 3.03.
4. The names of both the IEMs are to be mentioned in the NIT. A one page brief of the work is to be forwarded to the IEMs by e-mail while releasing NIT as circulated vide AAI.PMQA/7001/2014/dated 15th October,2014 and a copy of the same should be endorsed to gmpmqa@aii.aero.
5. In case of procurements without call of tenders like DGS&D rate contract, purchase through direct negotiations etc. IP has to be got signed for all procurements falling in the above limit before acceptance of the offer.
6. NIT approving authorities are required to ensure that IP is incorporated in the contract.
7. The revised threshold limit will apply for all procurements for which tenders are invited on 10/10/2016 or thereafter.
