Subject: Reg. Admissibility of CATC Instructor & OJT Instructor allowance

Reference to circular dated 1st December 2006 on the subject matter, it has been decided to reiterate the rate of CATC Instructor & OJT Instructor allowance as mentioned below:

A. CATC Instructor Allowance:

- (i) GM/Jt. GM/DGM - Rs. 9500/- pm
- (ii) AGM/SM/Manager/AM - Rs. 7500/- pm

B. OJT Instructor Allowance:

- (i) GM/Jt. GM/DGM - Rs. 4500/- pm
- (ii) AGM/SM/Manager/AM - Rs. 3500/- pm

2. These allowances are applicable for only those officials who are engaged in instructional duties. Principal CATC will not be eligible for Instructor allowance.

3. However, in an event, due to operational exigency, if an official at training institute has been given additional/temporary charge as Principal CATC, then, he/she will be eligible for instructor allowance subject to the condition that he/she is

performing instructional duties till the time new incumbent joins or he/she permanently appointed as Principal CATC.

4. This issues with the approval of competent authority.

Sub: Revision of CATC Instructor & OJT Instructor Allowance

The CATC Instructor & OJT Instructor Allowance was last revised w.o.f. 01.12.97 vide Office Order No.A.60011/71/97-PP dated 07.02.1998. The issue to further revise the said allowance on revision of pay scales of Executives was under consideration of the Management. It has been decided to revise the CATC Instructor Allowance and OJT Instructor Allowance to the eligible Executives of CNS & ATM Directorate as follows:

A. CATC Instructor Allowance

- GM/Joint/Addl. GM/DGM @40% of Basic Pay subject to max. of Rs. 9500/pm
- AGM/SM/Manager/AM @40% of Basic Pay subject to max. of Rs. 7500/pm

B. OJT Instructor Allowance

- GM/Joint/Addl. GM/DGM @20% of Basic Pay subject to max. of Rs. 4500/pm
- AGM/SM/Manager/AM @20% of Basic Pay subject to max. of Rs. 3500/pm

2. The above allowance is effective from 01.04.2000 & will be valid for a period of five years.

3. The other terms & conditions as circulated from time to time shall remain unaltered. This issues with the approval of Competent Authority.
