2. In order to address the extra-ordinary situation, the Competent Authority has approved the following till further orders –

a) The officials of AAI (serving & retired) is permitted to take treatment of COVID-19 in any hospital (empanelled or non-empanelled) where the beds/rooms are available.

b) The reimbursement of the expenditure incurred on the medical treatment shall be done on production of bills.
