

Schedule of Parking Tariff:

1. Parking Fee will be charged from all vehicle entering the designated parking area, detailed below:
 - a. Introductory slab for up to 30 minutes to be implemented based on the category of the Airport:

Coach/ Bus/ Truck (for both pick and drop)	170
Temp/ SUV/ Mini Bus (more than 07 seats)	60
Commercial Car (Authorized Licensee of AAI/DEOGHAR AIRPORT LIMITED)	20
Commercial Car (Vehicles which are not Authorized Licensee of AAI/DEOGHAR AIRPORT LIMITED)	1.2 x *Rate of Ola/ Uber per Trip = Rs 50
Premium Car parking	75
Pvt. Car/ SUV (upto 07 seats)	30
Two-Wheeler	10

Note: Proposed rates are inclusive of all taxes including GST, if applicable.

- b. Rate as per existing slab will be applicable from 30 minutes to 120 minutes, the same is also reproduced below:

Premium Car parking	80

Classification of Airports based on Pax as per AAI/DEOGHAR AIRPORT LIMITED Policy
(Deoghar Airport Limited is a “D” Category Airport)

For Four wheelers, after two hours, rate will increase by Rs. 20/- per hour in case of Group A (including Kolkata/Chennai) and Rs. 10/- per hours in Group B&C.

For two wheelers, the charges after 2 hours will be Rs. 10/- per hours at Group A and Rs. 5/- for Group B&C. The parking rate beyond 7 hours up to 24 hours will be 300% of the “30 minutes to 120 minutes slab” and every 24 hours or part thereof. (as per existing rates).

2. The monthly charges in respect of employees of AAI/DEOGHAR AIRPORT LIMITED and other authorized agencies working at airport, cargo complex will be as follows (as per existing rates):

Cars	Rs. 500/-
Two Wheelers	Rs. 250/-

Note: Monthly passes are not applicable on Tempo & Truck operators at Cargo complex and Agent/Licensee at Cargo complex.

ATM cash vans coming to refill ATM machines in airport premises shall be exempt from parking charges as well as Excess Time Fee.

Govt. owned vehicles shall be exempted from car parking charges and excess time fees.

3. The rate of Parking Fees and Excess time fees are inclusive of components of GST. Accordingly, these shall remain the parking charges applicable to end users. However, NIT/ Agreement conditions should clearly stipulate that though the above shall be the parking charges applied to end users, but the onus of depositing all applicable taxes prevailing during contract period at the station including GST in respect of fees collected for car parking charges shall rest with the licensee. The details of GST/applicable tax shall be depicted in the car parking invoice issued to end-users.
4. Vehicles which have been penalized for the infractions are not liable to pay excess time fees to Vehicle Parking Concessionaire.

c)	Parking charges beyond 120 minutes upto 07 hours (eg. For 07 hours parking tariff)	Rs. 40+ Rs. 10x5 hrs = 90
d)	For pvt cars wheelers staying beyond 7 hours upto 24 hrs parking charges will be (300% of 30-120 minutes slab) for eg. 24 hours case.	(300% of 30-120 minutes slab) Rs. 65 x 30 = Rs. 120
e)	Parking charges beyond 24 hrs (For Eg. 36 Hours)	Rs. 120 + 120 x (12/24) = Rs. 180

1. After two hours, rate will increase by Rs. 20/- per hours in case of Mega/ Group A and Rs. 10/- per hours in Group B/C/D/Others		
2. The Parking rate beyond 7 hours upto 24 hours will be 300% of the 0-30 minutes to 120 minutes" slab and every 24 hours or part thereof.

S. No.	Parking duration slab	Group B/C/D/Other (in Rs.)
a)	Parking charges for 0-30 Minutes	10
b)	Parking charges beyond 30 minutes upto 120 minutes	15
c)	Parking charges beyond 120 minutes upto 07 hours (eg. For 07 hours parking tariff)	Rs. 15 + Rs. 5 x 5 hrs = Rs.40
d)	For Two wheelers staying beyond 7 hour upto 24 hrs parking charges will be (300% of 30-120 minutes slab)	(300% of 30-120 minutes slab) Rs. 15 x 3 =Rs. 45
e)	Parking charges beyond 24 hrs (For Eg. 36 Hours)	Rs. 45+45 x (12/24) = Rs. 67.5
f)	Parking charges beyond 24 hrs upto48 hrs (for example 48 hours)	Rs. 45 x 2 = Rs. 90
