
Sub: License fee for land/space allotted to the contractor during execution period-reg.

1. AAI in its 208th Board meeting held on 13.05.2022 under Agenda No. 208.12 passed the following resolution that *"In future tenders, land/space (Paved/Unpaved/Covered-AC/Non-AC), to the extent allotted to contractors during execution of Civil/ Electrical/ CNS works for the purpose of installation of plants, labour camps, cement godown, site office, stacking of materials shall be provided at free of cost upto defect liability period/ maintenance period. A security deposit towards land allotted shall be deposited by the contractors as per AAI Engg. Works Manual (presently Rs. 500/- per sqm) and refunded only after vacation of the allotted land. If contractor fails to vacate the allotted land/ space (Paved/ Unpaved/ Covered-AC/ Non-AC) after Defect Liability Period/ Maintenance Period of a particular work shall be charged as per prevailing licence fee of the airport plus 25% penalty over that."*
2. Accordingly, Clause- 37 of GCC 2017, AAI has been modified as under:

3. The Clause 37 of GCC shall be modified accordingly for the forthcoming tenders. This provision shall also be part of the tenders under process and suitable corrigendum shall be issued in due course.
