QUALIFICATION & EXPERIENCE :

- Jr. Assistant (Office) : Graduate + 30/25 wpm. English/Hindi Typing Speed with 2 years relevant experience in the concerned discipline. Computer knowledge is desirable.
- Jr. Attendant (Office) : 8th preferably 10th pass and knowledge of related trade.
- Jr. Attendant (Engg. - Elect.) : Should have good physique.

AGE LIMIT (AS ON 01.08.2007)

- Jr. Assistant (Office) : Below 30 years
Jr. Attendant (Office/Engg. - Elect.) : Below 27 years

SELECTION PROCESS :

- Jr. Assistant (Office) : The selection shall be made on the basis of a Written Test/Type Test/Interview.
- Jr. Attendant (Office) : The selection shall be made on the basis of Interview.
- Jr. Attendant (Engg. - Elect.) : The selection shall be made on the basis of Interview and Trade Test (wherever applicable).

CONCESSIONS FOR SC/ST

- Upper Age limit is relaxable by five years.
- No application fee
- Candidates not working in Govt./Autonomous Body/PSU, will be paid second class Rail Fare for interview only by the shortest route as per AAI rules.

CONCESSION FOR OBC

Upper Age limit is relaxable by three years.

CONCESSION FOR J & K RESIDENTS.

Upper Age limit is relaxable by five years in respect of the candidates who had originally domiciled in the State of Jammu & Kashmir during the period from 01.01.80 to 31.12.89.

CONCESSION FOR Ex-SERVICEMEN

Age relaxation as per Govt. rules.

CONCESSION FOR PHYSICALLY HANDICAPPED

- Upper Age limit is relaxable by 10 years
- No application fee.

The concessions are subject to furnishing an attested copy of the certificate (s) as proof of belonging to SC/ST/OBC and other categories from a Competent Authority in the format prescribed by Government of India.

GENERAL :

- Selected candidates will be initially posted in the offices under the control of Regional Office. However, they are liable to be transferred anywhere in India.
- Besides Basic Pay, DA, CCA, HRA others benefits such as Medical, LTC, Leave Encashment, Gratuity, PF etc. admissible as per AAI rules also will be paid.
- Employees of Govt./Public Sector Undertaking/Autonomous Body should forward their application through proper channel.
- The written test will be held at Delhi/Mumbai/Kolkata/Chennai/Guwahati/Allahabad/Ahmedabad/Hyderabad/Nagpur and Thiruvananthapuram. The number of centres can be reduced/increased depending upon number of application/nomination received, and in that case, the candidates will be adjusted at the nearest centre.
- The eligibility with respect to age, experience etc. will be determined as on 01.08.2007. The candidates who have appeared in the final degree exam before the last date of receipt of applications, can also apply. However, the candidates would be provisional subject to their acquiring the prescribed qualifications before the written exam/interview as the case may be.

- f) 50% of the above vacancies, as a one time measure, would be earmarked for the ad-hoc employees whose services were terminated vide AAI letter dated 30.11.2004 and in terms of the order passed by Hon'ble Delhi High Court on 30.04.2007. These candidates will be given relaxation in upper age limits without any age bar.
