The eligibility criteria and terms and conditions for engaging consultant/specialist are as under:

The period of engagement shall be for one year which may be extended upto three years on mutual agreement/satisfaction of AAI.

Eligibility Criteria

1. Qualification/ Age/ Honorarium/Duties & Visits

(i) **For Specialist:** MD/MS in their respective field from a recognized University as per MCI norms/regulations. The consultant shall be registered with the State Medical Council/Medical Council of India. Age between 45 to 70 years. Rs. 2000 (two thousand only) per visit inclusive of conveyance. Two days in a week for 02 (two) hrs.

(ii) **For General Physician:**

MBBS from a recognized University as per MCI norms/regulations. The consultant shall be registered with the State Medical Council/Medical Council of India. Age between 40 to 65 years. Rs. 2000 (two thousand only) per visit inclusive of conveyance. Six days in a week for 06 (six) hrs.

- (iii) **Physiotherapist:** Post Graduate i.e. MPT, preferably in musculoskeletal i.e. Ortho from a recognized Institution/ University. The candidate shall be registered with the Physiotherapy Council, State/India. Age between 30 to 50 years. Rs. 1250/- (twelve hundred fifty only) per visit inclusive of conveyance. Four days in a week for 03 (three) hrs.
- (iv) **Nursing staff:** B.Sc. (Hons.)/regular course in B.Sc./Post Basic B.Sc. in Nursing from a recognized University or Institutions. Age between 30 to 60 years. Rs. 1000/- (one thousand only) per day for six days in a week for 06 (six) hrs.

2. Experience:

(I) **For Specialist:** Ten years of working experience from a Government Hospital/Private Hospital of repute after obtaining PG Degree. Retired Doctors from the Government Institutions will be preferred.

(ii) **For General**

Physician: Five years of working experience from a Government Hospital/ Private Hospital of repute. Retired Doctors from the Government Institutions will be preferred.

(iii) **Physiotherapist:** Two years experience from Government Hospital/Private Hospital of repute after Post-graduation.

(iv) **Nursing Staff :** Six months experience in minimum fifty bedded hospital after acquiring the educational qualification or Diploma in General Nursing and midwifery from a recognized board of council & Registered as a Nurse or Midwife with State Nursing Board of Council.
