NOTICE FOR EMPANELMENT OF ARBITRATORS

Airports Authority of India intends to form a panel of arbitrators who can arbitrate upon disputes related to various contracts executed between AAI and its contractors, Joint Venture Partners and other stakeholders.

Therefore, AAI requests applications from candidates capable to arbitrate upon the disputes arising out of legal issues, contract management and infrastructure projects related to aviation industry, etc.

[A] The following are eligible to apply:

- a) Retired, Supreme Court and High Court Judges;
- b) Retired, Secretary & Additional Secretary to Government of India, Chief Secretary & Additional Chief Secretary of State Government;
- c) Retired, Chairman, AAI and Board Member, AAI;
- d) Retired, Director General & Additional Director General of CPWD, PWD MES;
- e) Retired, Chairman & Members of Railway Board;
- f) Independent External Monitors deputed by CVC for AAI for the cases where they were/are IEM.
- g) Law Officers retired from PSUs/ Government Department to the level of General Manager & above.

The applicant should be below 70 years of age as on 01.07.2022.

[B] TERMS AND CONDITIONS FOR EMPANELMENT:

1. Term of the panel will be for a period of 03 (Three) years from the date of empanelment which may be renewed after 03 years at the sole discretion of AAI. However, AAI reserves its rights to scrap the panel before the expiry of 3 yrs. AAI also reserves the right to expand the panel on need basis anytime during currency of the panel.

2. Empanelment, remuneration and other terms & conditions shall be governed by the provisions of the Arbitration and Conciliation Act, 1996, more specifically, Section 12 read along with Schedule V and VI. The fees of the Arbitrator shall be in accordance with the provisions of Schedule IV of the Arbitration and Conciliation Act, 1996, as amended from time to time.
