Please bring the following documents in **ORIGINAL** along with a copy of the call letter for verification of your age, educational qualification, GATE qualification, Caste Certificate, disability certificate etc. In case of your absence or non-production of certificates, your candidature will not be considered for final selection :-

- Secondary School Marksheet and Certificate indicating Date of Birth as proof of Age.
- Higher Secondary School Marksheet and Certificate
- Bachelors' / PG Degree Certificates (as applicable)
- Semester -wise / Consolidated mark sheets of Bachelors' / PG Degree Examination as applicable
- Where only CGPA/DGPA/OGPA/CPI is awarded in the mark sheet, candidate will have to produce the certificate/document indicating conversion formula of University for equivalent percentage of marks as per norms adopted by issued by the University/Institute (minimum 60%).
- GATE 2020/2021/2022 Score card in original (whichever is applicable).
- Specialization order/letter indicating the Authority (with number and date) clearly specifying the specialization in the degrees, if specialization is not mentioned on the degree/Mark sheet of qualifying degree,
- Completion certificate of Apprenticeship training in AAI, in support of claim for exemption of application fee.
- Caste Certificate of SC, ST, or OBC (Non-Creamy Layer if applicable. OBC (Non-creamy layer) Certificate must be issued in the current financial year i.e., 2022-23, in the format prescribed for Recruitment to Central Government Service.
- Income and Asset Certificate in the prescribed format for the current financial year 2022-23, in case of EWS candidates.
- Disability Certificate issued on or before 21/01/2023 by the Competent Authority as per the Govt of India guidelines.
- Discharge Certificate in case of ex-serviceman.

- NO OBJECTION CERTIFICATE in original from the present Employer if working in Central/State Government, Autonomous body or Public Sector Undertaking. Other claims such as undertaking to resign in the event of selection, acknowledged copy of application for NOC / resignation letter, experience certificate etc. shall not be considered in place of NOC.
  - An affidavit in original in case of any discrepancy in name of self, parents or address etc. in any of the requisite documents.
  - One ID proof in ORIGINAL i.e. Voter ID/Aadhaar card/Driving License/Passport, etc. having the permanent or present address as given in the application
  - One set (self-attested) photocopy of all the above documents including photocopy of call letter
  - One Passport size photograph
  - Any other relevant document

  5. No request for change of Date, Time and Venue for document verification will be entertained. Call letters will be sent on registered email IDs shortly. Link for downloading call letters will also be made available on AAI website.

You will be reimbursed AC II Tier Train fare or actual Bus fare by shortest route from the correspondence address on submission of self-attested copy of ticket/e-ticket generated for the journey, provided the distance travelled by Rail/Bus each way exceeds 80 Kms. Candidate has to provide IFSC code, Bank Account Number and submit a copy of this call letter on the day of Document Verification. In case of air travel, boarding pass is also to be submitted.
