

**CORRIGENDUM TO AIC 14/2020**

The Airports Economic Regulatory Authority of India (AERA) has issued a Corrigendum date 4<sup>th</sup> August 2020 to their Order No. 24/2020-21 dated 2<sup>nd</sup> July, 2020 regarding provision of compensation in lieu of Fuel Throughput charges at Chaudhary Charan Singh International Airport, Amausi, Lucknow (CCSIA) for the period from 15.07.2020 to 31.03.2021 or till determination of aeronautical charges for the 3<sup>rd</sup> Control Period. **In the matter of Provision of Compensation in lieu of Fuel Throughput Charges (FTC) at Chaudhary Charan Singh International Airport, Amausi, Lucknow (CCSIA).**

1. The Authority vide Order no. 24/2020-21 dated 02.07.2020 determined additional Landing Charges in lieu of the abolished FTC charges (Ref. MoCA Ir. No.AV.13030/216/2016-ER (Pt.2) dated 08.01.2020) for Chaudhary Charan Singh International Airport, Amausi, Lucknow (CCSIA), effective from 15.07.2020.
2. Subsequent to the issue of Order, it is noticed that there is some error in the Tariff Card to be levied from 15.07.2020.

**ORDER**

3. The Authority, in exercise of powers conferred by Section 13(1)(a) of the Airports Economic Regulatory Authority of India Act, 2008, and, the facts and clarifications placed on record before the Authority, decides and orders that :

**3.1 Landing charges for the period from 15.07.2020 to 31.03.2021 as specified in the tariff card annexed to Order no. 24/2020-21 dated 02.07.2020 may be read as follows:**

**Rate per Landing - International Flight**

Weight of the Aircraft	Revised Rate Per Landing Approved by AERA (In ₹)
Up to 25 MT	₹ 294 per MT
Above 25 MT up to 50 MT	₹ 7,350 + ₹ 601 per MT in excess of 25 MT
Above 50 MT up to 100 MT	₹ 22,375 + ₹ 699 per MT in excess of 50 MT
Above 100 MT to 200 MT	₹ 57,325 + ₹ 797 per MT in excess of 100 MT
Above 200 MT	₹ 1,37,025 + ₹ 920 per MT in excess of 200 MT



**Rate per Landing - Domestic Flight**

Weight of the Aircraft	Revised Rate Per Landing Approved by AERA (In ₹)
Up to 25 MT	₹ 294 per MT
Above 25 MT up to 50 MT	₹ 7,350 + ₹ 392 per MT in excess of 25 MT
Above 50 MT up to 100MT	₹ 17,150 + ₹ 454 per MT in excess of 50 MT
Above 100 MT to 200 MT	₹ 39,850 + ₹ 515 per MT in excess of 100 MT
Above 200 MT	₹ 91,350 + ₹ 576 per MT in excess of 200 MT

4. All other charges, and, terms & conditions, as determined vide AERA Order No. 37/2017-18 dated 16.02.2018 & Order no. 24/2020-21 dated 02.07.2020 shall remain applicable.
