The reply to the RTI Queries specific to NSCBI Airport, Kolkata are as under :-

NSCBI Airport, Kolkata is operated by Airports Authority of India (Public Sector Enterprise). At NSCBI Airport, Kolkata wheelchair service is provided to disabled passengers by concerned airlines and the record is maintained with the airlines.
2.	There is a provision of ramp for disabled people in all the Airports, National Airports, International airports and others operated by the Government of India. If yes, please provide ramp photo. Kindly tell me with full details.	Yes, there are total 8 nos. of ramps with stainless steel railings available at NIPTB of NSCBI Airport, Kolkata in arrival, departure area including Volvo bus stand area. Photos for the same are enclosed herewith.
3.	Disabled adapted accessible toilets are available in all airports operated by the Government of India, national airports, international airports and others. Kindly tell me with full details.	Yes, there are 26 (twenty six) nos. of disabled adapted accessible toilets in passenger area at arrival and departure level of NIPTB of NSCBI Airport, Kolkata. All facilities pertaining to PRM norm are provided at these toilets. Photos for few of them are enclosed herewith. Moreover, Kolkata Airport has been adjudged as Best Airport in terms of availability of PRM facility.
4.	Moving chairs are available for disabled people in all airports, national airports, international airports and others operated by the Government of India. Available in what number? Kindly tell me with full details.	At NSCBI Airport, Kolkata wheelchair service is provided to disabled passengers by concerned airlines and the record is maintained with the airlines.
