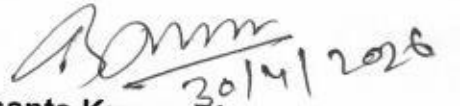

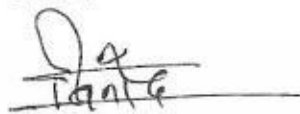

Sir

I am in receipt of the replies furnished by your office in response to my RTI applications dated 10 03 2026 and 27 03 2026

Upon perusal of the replies it is evident that the information provided is incomplete evasive and contrary to the provisions of the RTI Act 2005

The denial of contract details under section 8 1 d is legally unsustainable as the information relates to a public contract involving public resources and is squarely covered under public interest disclosure

Further repeated responses stating that the queries are not specific despite clearly defined time periods reflect non application of mind and deliberate withholding of information

The refusal to disclose the name and designation of the responsible officer is also unjustified and contrary to settled principles of transparency

Additionally directing the applicant to refer to the website instead of furnishing copies of documents does not amount to compliance under the RTI Act

The annexed material also indicates lack of proper display and clarity regarding free parking duration which raises serious concerns of public inconvenience and possible overcharging

In view of the above I am constrained to state that the replies furnished are legally deficient and violate the statutory obligations of the Public Information Officer

Accordingly I shall be filing a First Appeal under section 19 1 of the RTI Act and if necessary a Second Appeal before the Central Information Commission

Further in case of continued non compliance I reserve my right to seek appropriate relief before the Honorable High Court under writ jurisdiction

You are therefore requested to reconsider the matter and furnish complete and correct information at the earliest
