4.	Kindly clarify whether EWS candidates selected on their own merit were adjusted against: (a) Unreserved (UR) vacancies, or (b) EWS reserved vacancies.	
5.	Kindly provide the total number of EWS candidate who were finally selected against UR merit.	
6.	Kindly provide information whether any EWS reserved vacancy remained unfilled and was subsequently adjusted/transferred to the unreserved category.	
7.	Kindly provide the detailed reason, rule Or basis for the increase in EWS cut off mark from 52 marks in the 2 nd stage shortlist result to 63 in the final selection result.
