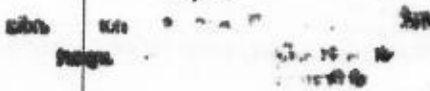

The evaluation method was as per the Codal procedures only. Sri Vijaya Puram in South Andaman is a remote island location with limited demand and supply for medical facilities based on population. In this regard the HSP has fulfil the requirements of 50 bed capacity in case such a requirement arises.
