 4. Your candidature will NOT be considered for selection, in case you do not fulfil any of the conditions in the advertisement vide Advt No. ER/01/2024 or if you fail to produce any one of the above listed documents in original for verification without giving any further reference.
 5. No request for change of Date, Time and Venue will be considered under any circumstances. No correspondence in this regard will be entertained.
 6. **If any candidate fails to bring the original and self-attested photocopy of the above said documents for verification, he/she will be debarred/rejected from appearing for the next stage of selection. His/her candidature for further selection process will be summarily rejected. Candidates who are domiciled in the States/Union Territories (West Bengal, Bihar, Odisha, Chhattisgarh, Jharkhand, Andaman & Nicobar Island and Sikkim) shall only attend the tests. Candidates who are domicile of other states/UTs other than mentioned above shall be summarily rejected in the Document Verification process.**
 7. The test shall consist of the following (each one being elimination round) :-
 - (a) Physical Measurement Test: The authorized doctors from Govt/AAI empanelled hospital will examine the Physical standards of the candidates as per specification stated in Advt. No. ER/01/2024. Candidates declared "UNFIT" by the medical board will not be allowed to appear for further stage of selection.
 - (b) Driving Test : Candidates qualified in the Physical Measurement Test shall be permitted for Driving Test using Light Motor Vehicles as stated vide Advt. No. ER/01/2024. Candidates declared "FAIL" by the Examiner will not be permitted to appear for further stage of selection process.
 - (c) Physical Endurance Test: Candidates who pass Driving Test will only be permitted to appear for Physical Endurance Test.
 8. Minimum qualifying marks for Physical endurance Test for both male and female candidates shall be 60 out of 100.
 9. The Physical Endurance Test shall be qualifying in nature and to get qualified, candidate has to score minimum total marks of 60 in the Five (05) prescribed Physical Endurance Test. The final merit list in respect of selection for the post of Jr. Assistant (Fire Service) shall be made on the basis of written examination marks (Computer Based Test – CBT) only.
 10. The above schedule is subject to change/extension at the sole discretion of the management of Airports Authority of India. The schedule may be verified from the Date wise Schedule published in the career dashboard of AAI website.

11. You will be reimbursed AC III Tier rail fare (including Rajdhani Express) or actual bus fare by the shortest route through electronic transfer, subject to production of original travel proof and bank details/cancelled cheque, provided the distance travelled by Rail/Bus each way exceeds 80 Kms.
