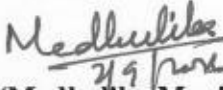

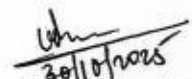

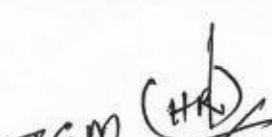

4. As of now, no decision has been received from the Ministry regarding processing of Pension Cases in r/o CAD Pensioners who have drawn EPFO Pension.
5. A meeting was held on 22.04.2025 in the Ministry of Labour & Employment, where it was advised that MoCA may consider taking an administrative decision regarding the payment of differential pension (i.e., Government Pension minus EPFO Pension) in such cases, in view of EPFO's refusal to stop EPS pension. However, until any formal decision or direction is received from MoCA, the release of Government Pension arrears and Pension Payment Orders (PPOs) in respect of cases, who have drawn EPS Pension including that of Sh. 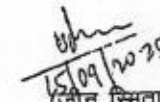

With due respect, I, **Shanicharwa Lohara** (Employee No. – 10020646), retired Senior Attendant (Radio Cleaner), Airports Authority of India, Birsa Munda Airport, Ranchi, retired from service on **30.06.2018**. I joined the organization on **08.11.1983**.

As I am a member of both **CAD Pension** and **EPS-95 Pension** schemes, I have been deprived of receiving the benefit of CAD Pension even after completion of 8 years. At present, through letter no.

AAI/Ranchi/HR/File-57/2128-29 dated 15.09.2025 issued by Airports Authority of India, Birsa Munda Airport, Ranchi, I have been informed that I am receiving benefits under the EPS-95 Pension Scheme, and therefore the commuted value of Government Pension / CAD Pension is not being released by Airports Authority of India, Corporate Headquarters, New Delhi, since two pensions are not permissible for the same service.

It is submitted that I fulfil all eligibility criteria for receiving Government Pension / CAD Pension from Airports Authority of India. In this regard, an amount of **₹13,96,766/-** (Rupees Thirteen Lakh Ninety-Six Thousand Seven Hundred Sixty-Six only) has already been deposited with the department vide contribution deposit letter no. **AAI/CPF/FP/ER/552 dated 27.06.2019**.

Therefore, I humbly request you to kindly arrange for the closure of my **EPS-95 Pension (PPO No. – JH/RAN/00079440)** scheme at the earliest so that I may receive the benefit of Government Pension / CAD Pension. And at the same time, it is requested to start my **CAD Pension**.

I shall always remain grateful for your kind action.

Sub:- Government pensionary benefits to employees transferred en-masse from the erstwhile Civil Aviation Department (CAD)/ DGCA to AAI, who had rendered less than 10 years of service in Government-reg

The undersigned is directed to refer to Ministry of Civil Aviation DO no. AV-24032/39/2023-AAI-MOCA dated 25.05.2023 seeking this Department's response on the proposal for grant of Government Pension, while adjusting the amount of EPS Pension received in respect of employees of erstwhile Civil Aviation Department (CAD) who were transferred en-masse to National Airports Authority (NAA) in 1989 and had rendered less than 10 years of service in Government.

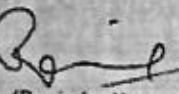
2. In this connection, MoCA vide their OM dated 11.01.2022 had referred such proposal for consideration of this Department. DoPPW vide OM dated 07.02.2022, had furnished the following comments to MoCA:-

"Rule 6(1) of CCS (Pension) Rules, 2021 [earlier Rule 7(i) of CCS (Pension) Rules, 1972] stipulates that a Government servant shall not earn two pensions in the same service or post at the same time or by the same continuous service.

In view of the clarification sought by MoCA as mentioned in para (1) above, it is stated that there is no such provision in the CCS (Pension) Rules, 2021. Therefore, this Department has no comments to offer in this regard. Hence, MoCA may take an administrative decision in the matter accordingly".

3. In view of the above and having conveyed the advice/stand of this Department vide OM of even no. dated 07.02.2022, this Department has no further comments to offer in this regard. MoCA may take an administrative decision in the matter in consultation with Ministry of Labour and Employment accordingly.

4. This issues with the approval of competent authority.
