Under the provisions of the Right to Information Act, 2005, I seek the following information regarding security arrangements at Netaji Subhas Chandra Bose International Airport, Kolkata:

Whether CISF security cover has been officially provided to the Airport Director (APD), Kolkata Airport or the Regional Executive Director (Eastern Region) posted at NSCBI Airport, Kolkata.

If yes, kindly provide:

1. The date on which CISF security was assigned.
2. The category or level of security provided (e.g., personal security officer, escort, etc.).
3. The reasons cited for the provision of such security (e.g., threat perception, intelligence inputs, etc.).
4. Whether this provision is a part of standard operating procedure for all senior officials across Indian airports or a special case.
5. A copy of any circular/order/communication regarding CISF deployment for individual security (not general airport security).
6. Any cost implications or changes in CISF manpower distribution at the Kolkata Airport due to this special security cover.

I request you to kindly furnish the above information at the earliest, within the stipulated time as per the RTI Act.
