Information Sought (जानकारी मांगी):	It is requested to provide the following information pertaining to all AAI airports and especially Tirupati Airport: 1. Is CISF posted to enforce rules or do protocol facilitation duties? If yes kindly mention the details of officials to whom they can extend courtesy and to what level? Can they extend courtesy to rich businessmen without security check and escort with QRT personnel? 2. Can CASO use lower rank people like washerman/dhobi/driver/cook at his house for personal works? 3. Do CISF have to display AEP or only other agencies have to display AEPs? 4. Who is responsible for issue of temporary passes during VVIP movements? 5. Does CASO have power to take people other than those who have been issued AEP to apron side during VVIP movements? 6. Does CASO have right to selectively enforce rules of BACS on certain contractors only? 7. Does CASO have power to collect money unofficially for enforcing AEP rules? 8. Does CSO,AAI report to CASO/CISF? 9. If so, then does CSO act as per BCAS/DGCA guidelines or as per CASO/CISF instructions? 10. Do CISF have privilege to do parties in hotels like Regalia every weekend and not pay bills? 11. Does CASO have power to overrule Airport Director?		

12. How many rooms can be allotted to CASO/CISF in airport?
13. Who is the responsible executive for Security of Airport? Is it Airport Director or CSO or CASO/CISF?
14. Do every agency need to have permanent agency only for entry into airport/airside?
15. In case of new agencies, can CASO reject entry saying escort from same agency is not available?
16. In case of running agencies, can CASO reject entry saying escort from same agency is not available? If yes, does the clause apply to CISF also?
17. Can CASO blackmail commercial entities for passes by way of CASH/KIND?
18. Is facilitation of VIPs job of Terminal dept or CSO or CASO?
19. If CSO and CASO are involved in facilitation, then what happens to Security aspect of airport
20. Can CASO get favours like utilization of Fortuner vehicles of Political affiliation like Annam Anita etc for personal use and allow them to apron during CM movements without passes?
21. Who decides the passes to be given during VVIP movements like CM? Is it CSO/CASO?
22. Can CASO take people without passes to apron side during VVIP movements like Chief Minister of AP? If so is the Z category security of CM compromised?
23. In name of security can CASO threaten any official working at airport?
24. Are airlines obliged to provide boarding passes without presence of person on instructions of CASO?
25. Can airlines officials be ordered to remove clothes/shoes/belts/gold chains/ spectacles/watches/rings/Airline id card etc everytime while passing through security check even while holding permanent AEP?
26. Can CISF not check official vehicle of CASO while entering Air side and only check other vehicles?
27. Can CISF contract driver not have permanent AEP and still be allowed into airside without any escort or any check?
