**PREAMBLE :->**

- This Order is made under Section 19 of RTI Act, 2005.
- An Appeal against this Order lies with the Central Information Commission, Room No.305, 2<sup>nd</sup> Floor, 'B' Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110 066.
- The Appeal may be filed within 90 days from the date on which the Order is made or is actually received.

**FACTS :->**

1. The background of the present online Appeal is that the Appellant, Shri Asolo Kent, initially filed an online RTI Application dated 16/09/2014, addressed to PIO/JGM(Aero), AAI, Dimapur Airport, seeking the information regarding 'Arrival and Departure of Dr. Vilumuthu Ramachandran, Director, NIT-Nagaland at Dimapur Airport since 2011 till date'.
2. Thereafter, the Appellant filed an online Appeal dated 20/10/2014 before the Ministry of Civil Aviation stating the ground, for non receipt of reply to his RTI Application from PIO, Dimapur.
3. The FAA/RED, NER has called for the Written Submission by the PIO, Dimapur before hearing the matter.

4. The Appeal was heard by the First Appellate Authority, NER on receipt of the Written Submission dated 18/12/2014 by PIO, Dimapur.

**FINDINGS :>**

After careful examination of the materials or records and submission, the First Appellate Authority observes as follows : -

1. The custodian of the requested information of the RTI applicant is the concerned airlines of Dimapur Airport. Accordingly, the request was forwarded to the Station Manager, Air India, Dimapur for providing the information vide PIO, Dimapur letter dated 08/10/2014. Moreover, it is also evident from the record that the reply to the RTI Application dated 16/09/2014 has not been provided within the statutory time limit. However, it is found that PIO, Dimapur has already been provided the reply to the RTI Applicant vide letter No. AAI/MR(Aero)/ RTI-57/5218-20, dated 10/11/2014 under intimation to DGM (Law)-RTI, AAI, CHQ, New Delhi.
2. The instant Appeal dated 20/10/2014 as on date has become infructuous. The intervening period of filing the Appeal and the date of RTI reply by PIO, Dimapur is very negligible. Perhaps the appellant might have received the reply after filing the instant appeal and if not, PIO, Dimapur is directed to provide a copy of the said reply dated 10/11/2014 to the Appellant.

**ORDER :>**

1. In the light of above, it is observed that nothing is left out in regard to the RTI request dated 16/09/2014 to deliberate further.
2. With this observation, the instant online Appeal dated 20/10/2014 is disposed of.
