2. That Sir, I was transferred to Dimapur in September 2000 and transferred back to Guwahati in September 2002.
3. That Sir, again I have been transferred to Lengpui Airport and relieved w.e.f. 18.9.2014.
4. That Sir, it is not understood as to why and under which special and unavoidable circumstance I have again been transferred to Lengpui while transfer policy does not permit such transfer. This transfer becomes unnecessary harassment to the undersigned at this stage of the service.
5. That Sir, I will be very much thankful to you if you kindly review the matter immediately keeping transfer order in abeyance till the decision of review of the matter to avoid unnecessary harassment due to no fault of mine and to avoid legal complacency.




