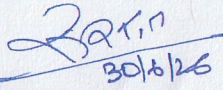

4.	Please provide the sanction strength details of Joint General Manager / Deputy General Manager (CNS) for Bhopal Airport, Indore Airport, Nagpur Airport, Raipur Airport, Jabalpur Airport.
