

PREAMBLE :->

- > This Order is made under Section 19 of RTI Act, 2005.
- > An Appeal against this Order lies with the Central Information Commission, Room No.305, 2nd Floor, 'B' Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110 066.
- > The Appeal may be filed within 90 days from the date on which the Order is made or is actually received.

FACTS :->

1. The Appellant above named submitted request under RTI Act, vide Application dated 04/02/2014, seeking information in relation to the Engineering works of LGBI Airport, Guwahati.
2. Having been aggrieved by the non-compliance to his request under RTI Act, the appellant above named, filed the instant appeal dated 01/05/2014, diarized on 23/05/2014 against the PIO, seeking information/documents in regard to his RTI Applications.
3. As per the Notice letter dated 10/06/2014, the matter is heard on 16/06/2014 at 1500 hours in the chamber of FAA/RED, AAI, NER, Guwahati. The Appellant was not present on the day of hearing. Over telephonic communication, the appellant informed that he is out of station and will submit his representation on return. But till date nothing has been received by this office.
4. The First Appellate Authority/RED, NER while deliberating the Appeal, made the following findings :-

FINDINGS :>

1. On perusal of the relevant records, it is gathered that the reply to the RTI Application dated 04/02/2014 is pending and it is also evident that PIO, NER, RHQ has failed to provide the information/documents due to non-submission of reply by the custodian authority (Engineering Directorate, NER) dated 10/02/2014, 03/03/2014, 07/03/2014, 13-14/03/2014 and 06/06/2014.
2. It is transparent from the records that PIO, NER sought desired information correspondence dated 10/02/2014, 03/03/2014, 07/03/2014, 13-14/03/2014 and 06/06/2014. But no response from the 'Treated PIO' is received till date.
3. However, it is also found that PIO has provided part information to the Applicant vide letter dated 06/06/2014 based on the materials received from the custodian authority.

ORDER :>

1. Under the facts and observations stated above, it is obvious that the information/documents sought by the Appellant, also mentioned in the instant Appeal dated 01/05/2014 are to be provided in the spirit of the RTI Act.
2. As such PIO, NER is hereby directed to provide the Appellant the remaining information/documents within 15 days from the date of receipt of this order in conformity with the provisions of RTI Act.
3. With this, the instant Appeal dated 01/05/2014 merits dismissal.
4. However, the Appellant Lt. Col. Vibhav, if wishes so, may like to file an Appeal against this Order before the Hon'ble Central Information Commission, Room No. 305, 2nd Floor, 'B' Wing, August Kranti Bhavan, Bhikaji Cama Place, New Delhi - 110 066 within the statutory time period as mentioned in the over leaf.
