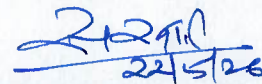

B. Criteria to nominate the CNS executive for Foreign training at OEMs premises:

1. The nominee shall be below 54 years of age as on date of commencement of training.
2. The nominee shall be 53 years of age for SMU training or training for a system where the tenure is four years.
3. The nomination shall be made among the proficient executives only.
4. Nominations shall be made based on seniority among the eligible and suitable candidates.
5. Nominee shall not be due for tenure and Out of Region posting. However, if equipment is installed at tenure or in out of region stations then nomination of such candidates can be considered.
6. The nominees shall not have refused any foreign training during the last five years.
7. Second chance for foreign training shall be considered only when all other eligible candidates have also availed their first chance for foreign training. Nominations shall be done on the basis of the date of last foreign training attended.
8. Seniority and number of previous foreign trainings will be given consideration as appropriate for shortlisting.
9. Representation of reserved category executives fulfilling the eligibility criteria will be considered as appropriate.
10. The information furnished while applying for an FT is sole responsibility of ATSEP applying for that FT. Any incorrect/ fraudulent information provided shall lead to immediate debarment from any Future training for 05 Years as well as withdrawal of all Rating allowances upon committee recommendation along with penalty as per provisions mentioned in AAI ECDA regulation 2003.

After foreign training, the executive has to serve for a minimum period of 3 years at the station where the equipment is installed.
