S.No.	Question	Reply
1.	Tell me about expansion of Indore airport. required land detail.	Total 143 acres of land is requested from State Govt. for the expansion of Indore Airport.
2.	Cost of current land.	Land is to be acquired by State Govt. Therefore, CPIO is not custodian of desired information.
3.	Proposed plan. Benefits to Indore	The desired information falls under the RTI – act 2005 clause no. 8(1) (a) and hence can't be shared with applicant.
4.	Benefits of Indore	Expansion of the airport will facilitate the Code-E type of aircraft operation & increase in the airport capacity.
