Sealed Quotations are invited for running of AAI Staff Canteen at ATS Complex, Imphal Airport, Imphal subject to the following conditions:-

- i) Permission shall be granted for a period of three years and can be terminated by giving 30 days time on non-satisfaction of services.
- ii) Canteen shall be available from 06:00 A.M. to 09:30 P.M. for providing Tea/Coffee/Cold Drinks, Snacks, Breakfast, Dinner daily at rates recommended by management committee from time to time as per enclosed Annexure.
- iii) Jurisdiction of sale of items will be within ATS complex, serving items to staff in NTB/Fire/MT/Power house permissible to the staff posted in the location.
- iv) Canteen should be kept clean & tidy at all times. Food & Beverages shall be served in a hygienic condition to all AAI employees.
- v) Minimum lump sum license fee @ Rs.500/- per month only for kitchen shall be charged and electricity & water charges on actual consumption at AAI rates as revised from time to time.
- vi) Minimum security deposit of Rs.2000/- lump sum shall be charged in advance preferably by DD in favour of AAI, payable at Guwahati. Security deposit shall be 04 (four) times of the license fee.
- vii) Contractor may charge different rates from other agency's staff/users.
- viii) Sale of liquor, intoxicating drinks, drugs etc. shall be strictly prohibited.
- ix) Persons working for the services of AAI Staff Canteen should not be suffering or suspected from any infectious diseases and also under influence of any intoxicants.
- x) Persons shall be in clean dress and in good conduct manners at all the times.
