1. Kindly provide copies of the DGCA certificate and related documents concerning the operational approval of Solapur Airport.
2. Please share the Standard Operating Procedure (SOP) followed for renovation and reconstruction at Solapur Airport.
3. Provide details of the total expenditure incurred on the renovation and reconstruction of Solapur Airport, along with year-wise breakdown and a description of the specific works undertaken.
4. Please furnish details of the yearly operational cost of Solapur Airport, including all expenses such as staff salaries, maintenance, utilities, and other administrative costs.
5. Kindly provide an update on the expected commencement date for scheduled passenger flights from Solapur Airport.
6. Share details of the airline companies that have shown interest in operating flights from Solapur Airport, along with proposed routes.
7. Provide data on the yearly number of landings and take-offs at Solapur Airport for the past five years.
8. Kindly provide the fee structure for various aircraft types using Solapur Airport, including landing, parking, and other charges.
9. Share the list of members of the Solapur Airport Advisory Committee, along with the criteria for their selection, their terms, and details of any remuneration or allowances provided to them.
10. Please specify the exact date when commercial passenger flights from Solapur Airport are expected to commence.
11. Why was refueling infrastructure not included during the recent renovation? What is the current status regarding refueling facilities at Solapur Airport?

I request that the information be provided in a clear and structured format. If any of the requested information is exempt under the RTI Act, please provide the reasons for the same as per the relevant sections of the Act.

Kindly provide the requested information within the stipulated timeframe as per the RTI Act, 2005.
