

3 Please provide certified copies of all communications received by AAI from the Ministry of Women and Child Development MWCD regarding establishment of breastfeeding feeding rooms or mother child friendly facilities at airports along with copies of replies or action taken reports submitted by AAI.

4 Please provide airport wise details of facilities available for mothers including dedicated feeding rooms baby changing stations seating washbasins sanitizers privacy measures safety arrangements and whether these facilities exist in both arrival and departure terminals.

5 Please provide certified copies of inspection reports audits maintenance SOPs and complaint records relating to breastfeeding feeding room facilities at AAI airports along with action taken on such complaints.

I request that the reply be uploaded on the RTI Portal and also provided in PDF format.
