

### **1.0 PREAMBLE**

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

### **2.0 FACTS:**

- 2.1 Sh. Sarang Vaman Yadwadkar had submitted RTI application dated 20.12.2024 to PIO, WR regarding 'A copy/copies of agreements between AAI and the Aeromall/Owners of Aeromall/ OLA/Uber etc with respect to the operation/pickup by the cab services at Pune Airport.
- 2.2 PIO, WR vide e-mail dated 24.12.2024 transferred RTI application to PIO, Pune Airport for providing information directly to the applicant.
- 2.3 The Appellant filed first Appeal dated 20.01.2025 (received on 23.01.2025) before First Appellate Authority, RHQ, WR, Mumbai.
- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarized as under :

Brief of the RTI application filed by the appellant:

1. The applicant has sought information regarding A copy/copies of agreements between AAI and the Aeromall/Owners of Aeromall/ OLA/Uber etc with respect to the operation/pickup by the cab services at Pune Airport.'

2. All floor plans of Aeromall which are duly approved by the concerned authority.
3. Studies conducted if any till date with respect to the air pollution caused by Ola, Uber cabs at pick up floor of Aeromall.

### 3.2 FINDINGS:


From the records produced it is seen that applicant in his RTI application has sought information copies of agreement between AAI and the Developer of M/s Pebbles Infra Tech Pvt. Ltd. The PIO, Pune Airport vide letter no. पीओ/वि. नि/आरटीआय 2024/केस नं. 61/1146-47 dated 16.01.2025 informed applicant that sought information is exempted under section 8 (1) (d) of RTI Act, 2005. Placed on record is the correspondence mail dated 03.01.25 done by the concerned deemed PIO, Pune Airport with the third party i.e. M/s Pebbles Infra Tech Pvt. Ltd. Further, it is also seen that vide email dated 15.01.2025 developer M/s Pebbles Infra Tech Pvt. Ltd. Has denied to share the agreement copy. As per RTI Clause 8 (1) (d) that the information about commercial confidence, trade secrets, and intellectual property cannot be disclosed if it would harm a third party's competitive position. In view of above therefore no direction to PIO, Pune Airport is required in the matter.

### 3.3 ORDER:

With the above observations, the Appeal dated 20.01.2025 (received 23.01.2025) of Sh. Sarang Vaman Yadwadkar hereby stands disposed off.
