1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Sh. Rafique Rahemtulla Kabani had submitted RTI application dated 14.01.2025 to PIO, WR regarding Certified copies submitted by M/s AOS Housing Pvt. Ltd. for the plot no. E/87A, of Village Bandra, Mumbai.
- 2.2 The Appellant filed first Appeal dated 14.02.2025 (received on 17.02.2025) before First Appellate Authority, RHQ, WR, Mumbai.
- 2.3 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

The applicant has sought information Certified copies submitted by M/s AOS Housing Pvt. Ltd. for the plot no. E/87A, of Village Bandra, Mumbai.

3.1 **FINDINGS:**

From the records produced it is seen that applicant has sought Certified copies submitted by M/s AOS Housing Pvt. Ltd. for the plot no. E/87A, of Village Bandra, Mumbai. In this regard the Deemed PIO/Custodian of information i.e. GM (ATM), WR was requested to provide information. Accordingly for point no. (i) & (ii) GM (ATM), WR provided 13 pages of information. Accordingly vide letter no.52042/आरटीआय/केस)2025/34-एम 24/(dated 07.02.2025 it was informed to appellant to pay Rs.26/- @ of Rs.2/- for 13 pages within 15 days of receipt of this letter. Further, with regard to point (iii) to (ix) since information is not available with AAI, therefore vide letter no. 52042/आरटीआय/केस-3)2025/4एम/(47 dated 11.02.2025 the RTI application was transferred to PIO, Municipal Corporation of Greater Mumbai, Fort and copy of this letter is also endorsed to the applicant with a request to liaise with the above authority for further information. The applicant has filed first appeal stating that PIO failed to provide certified copies of information sought. In this regard it is seen that PIO, WR vide above letter dated 07.02.2025 has already informed applicant to pay document charges in order to supply the information for point no. (i) & (ii) and for remaining points (iii) to (ix) the RTI application has been transferred to another public authority. The appellant is advised to pay the requisite charges for documents, as requested by PIO, WR vide letter dated 07.02.25. The IPO of Rs. 20 enclosed with the appeal may be returned to the applicant as no fee is required for filing appeal.

3.2 **ORDER:**

With the above observations, the Appeal 14.02.2025 (received on 17.02.2025) of Sh. Rafique Rahemtullah Kabani hereby stands disposed off.
