1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Sh. Ram Prakash had submitted RTI application dated 27.12.2024 to PIO, WR regarding Widening of apron at Diu Airport near Stand 1. The RTI application was transferred to PIO, Diu Airport for providing information to the applicant.
- 2.2 The Appellant filed first Appeal dated 28.02.2025 before First Appellate Authority, RHQ, WR, Mumbai.
- 2.3 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

The applicant has sought information regarding

Widening of apron at Diu Airport

Use of Bay no.1 by airlines,

Designing shoulder extension for ARFF vehicle and fuel bowser,

Money spent for this purpose

3.1 **FINDINGS:**

From the records produced it is seen that applicant has sought information regarding widening of apron, use of Bay 1 by airlines, shoulder extension, money spent for this purpose etc.

As this information was pertaining to Diu Airport, therefore PIO, WR vide e-mail dated 07.01.2025 transferred RTI application to PIO, Diu Airport for providing information directly to the applicant.

The applicant has filed first appeal stating that no reply has been received till date. In this regard it is seen that PIO, Diu Airport vide letter no. AAI /DIU/APD/RTI/2025 dated 20.03.2025 has provided information to the applicant.


As per Section 7(1) of RTI Act, the time limit for providing information is 30 days from the receipt of the application. PIO, Diu Airport has provided information to the applicant after stipulated time period. On going through RTI application it is also observed that the applicant has sought the information in question form which should be dealt as per RTI Act, 2005. Also the section 2 (f) of RTI Act is not considered while providing information. Hence PIO, Diu Airport is directed to deal the RTI application as per RTI ACT in future.

3.2 **ORDER:**

With the above observations, the Appeal dated 28.02.2025 of Sh. Ram Prakash hereby stands disposed off.
