1.0 PREAMBLE:

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Sh. Shivratn Deepchand Rai had submitted RTI application dated 21.01.2025 seeking information regarding '**No Objection Certificate issued for height clearance vide letter dated 06.05.2019.**
- 2.2 The Appellant filed first Appeal dated 03.03.2025 before First Appellate Authority, AAI, RHQ, Mumbai stating that Information sought is not received.

3.0 FINDINGS & ORDER :

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

The appellant vide RTI application dated 21.01.2025 has sought information on 'Constructed height if the buildings with respect to permissible height granted in NOC letter dated 06.05.2019.

3.2 FINDINGS:

From the records produced it is seen that the appellant vide RTI application dated 15.03.2025 has sought information on 'NOC dated 06.05.2019 for

:2:

Height clearance. In this regard vide letter no. 52042/आरटीआय/केस-50/2025(एम)/59 dated 14/17.02.2025 it was informed to the applicant that No documented information available with this office.

The applicant has filed first appeal stating that Information sought is not provided by PIO. In this regard it is seen that information sought by the applicant is not available with AAI as stated by Deemed PIO & Custodian of information i.e. GM (ATM), WR vide ION NO. भाविप्रा-केस/आर टी आई/एस.ए.ओ.डी/क्षे.प/मु.क्षे/50/25/16 dated 12.02.2025. Accordingly it was communicated to the applicant. Under RTI Act the information which is available on record can be provided to the applicant. The information sought by the applicant is neither held nor under the control of AAI therefore information sought by the applicant can not be provided.

3.3 ORDER:

With this, the Appeal dated 03.03.2025 of Sh. Shivratan Deepchand Rai hereby stands disposed off.
