

### **1.0 PREAMBLE**

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

### **2.0 FACTS:**

- 2.1 Tripti had submitted RTI application dated 19.02.2025 to PIO, WR regarding Working hours of different posts of Operational cadres.
- 2.2 The Appellant filed first Appeal dated 26.03.2025 before First Appellate Authority, RHQ, WR, Mumbai.
- 2.3 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

The applicant has sought information regarding Working hours of different posts of Operational cadres.

**3.1 FINDINGS:**

From the records produced it is seen that applicant has sought information as Working hours per week for different posts of Operational cadres viz Sr. Asst. (Ops), Supervisor (Ops), Supdt (Ops), JE (Ops) & AM (Ops) . The applicant has sought circular regarding these working hours. In this regard the Deemed PIO & Custodian of information i.e. GM (HR) vide ION no. AAI/RHQ/WR/E-V/2025/94 DATED 18.03.2025 informed stating that The information sought by the applicant is not available in the recorded form but a copy of circular dated 06.01.2016 was provided by HR deptt.. Accordingly the above information was supplied to the applicant vide letter no. 52042/आरटीआय/केस-81/2025(एम)//87 dated 19.03.2025. The applicant filed first appeal on 26.03.2025 requesting to provide part information which is not disclosed. In this regard it is to mention here that under RTI Act the information already exists can be provided to the applicant. No record is created or generated for providing information to the applicant.

**3.2 ORDER:**

With the above observations, the Appeal dated 26.03. 2025 of Tripti Tripathi hereby stands disposed off.
