

1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Md. Ahsaan had submitted RTI application dated 14.01.2025 to PIO, Juhu Airport regarding Construction of hotel at Juhu Airport next to Juhu Airport entry gate, CTS no, 959, 959/1, 959/2, 959/3, 959/4 at Juhu Tara Road.
- 2.2 The Appellant filed first Appeal dated 25.03.2025 before First Appellate Authority, RHQ, WR, Mumbai.
- 2.3 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

The applicant has sought information regarding Construction of hotel at Juhu Airport next to Juhu Airport entry gate, CTS no, 959, 959/1, 959/2, 959/3, 959/4 at Juhu Tara Road.

3.1 FINDINGS:

From the records produced it is seen that applicant is seeking information regarding Construction of hotel at Juhu Airport next to Juhu Airport entry gate, CTS no, 959, 959/1, 959/2, 959/3, 959/4 at Juhu Tara Road.

The applicant in his appeal has stated that PIO neither communicated the decision nor supplied the information. In this regard it is seen that PIO, Juhu Airport vide letter no. भाविप्रा/जुहू/आर टी आय/2024-25/49 dated 17.03.2025 has informed applicant that information sought by applicant includes commercial confidence, disclosure of which would harm competitive position of third party & therefore exempted under section 8 (1) (d). The applicant is seeking complete file papers such as ATR notice, IOD CC, last approved plan, panchanam copy, CFO, tender copy of AAI, NOC, CRZ NOC, Enn DP, citizen objection letter Therefore PIO, Juhu Airport has rightly exempted information from disclosure under section 8 (1) (d) of RTI Act. Therefore, no further directions is required to be given to PIO, Juhu Airport in the matter.

3.2 ORDER:

With the above observations, the Appeal dated 25.03.2025 of Sh. Md. Ahsaan hereby stands disposed off.
