1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Sh. Saif Khan had submitted RTI application no. AAIMU/R/E/25/00045 dated 25.03.2025 to PIO, WR seeking information regarding 'The residential properties owned/leased by AAI in Mumbai Metropolitan Region.'
- 2.2 PIO, WR vide letter no. 52042/आरटीआय/केस-128/2025(एम)/104 dated 01.04.2025 returned RTI application to the applicant.
- 2.3 The Appellant filed first Appeal no. AAIMU/A/E/25/00011 dated 07.04.2025 before the First Appellate Authority, AAI, RHQ WR, Mumbai

3.0 FINDINGS & ORDER :

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

1. Availability of Residential Properties
2. Vacancy status
3. Leasing to other PSUs
4. Leasing procedure
5. Rent Rate
6. Individual rental for PSU employees
7. Rental /Lease agreement
8. Contract information

3.2 **FINDINGS:**

The applicant vide RTI application dated 25.03.2025 has sought information regarding the residential properties owned/leased by AAI.

PIO, WR vide letter no. 52042/आरटीआय/केस-128/2025(एम)/104 dated 01.04.2025 informed applicant that the RTI application is not as per Right To Information Act, 2005 and the RTI application was returned to the applicant .

The applicant has filed first appeal on the ground that information sought is refused.

On going through the RTI application it is seen that the information sought by the applicant is beyond the purview of section 2(F) of RTI Act 2005. As such a public authority can only provide information as defined under Section 2(f) of the RTI Act, 2005. In view of above no direction is required to be given to PIO, WR.


3.3 **ORDER:**
