1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Sh. Shridhar Sadashiv Dhanawade had submitted RTI application dated 12.03.2025 to PIO, WR regarding provide certified true copy of No objection Certificate issued by AAI to M/s Aishwarya Light Construction Company.
- 2.2 The Appellant filed first Appeal dated 18.04.2025 before First Appellate Authority, RHQ, WR, Mumbai.
- 2.3 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

1. Certified true copy of No objection Certificate (NOC) issued by Airport Authority of India to M/s Aishwarya Light Construction Company for the construction of the Rehabilitation Building (SRA)
2. Copies of all documents (including the Rehabilitation Building architectural plan and Sales Building architectural plans) as well as Request letters submitted by M/s Aishwarya Light Construction Company to your office for the purpose of building construction



3.1 **FINDINGS:**

From the records produced it is seen that applicant vide RTI application dated 12.03.2025 has sought copy of NOC issued by AAI to M/s Aishwarya Light Construction Company for the construction of the Rehabilitation Building SRA. The Deemed PIO/Custodian of information provided information containing 07 pages for which as per provisions of RTI Act vide letter no. 52042/आरटीआय/केस -67/2025(एम)/80 dated 07.03.2025 the applicant was informed to pay the document charges. However, instead of depositing document charges the applicant filed another RTI application seeking similar information. Seeking similar information repeatedly or filing multiple RTI requests or appeals shall be ground of refusal under the RTI Act, 2005. However, again vide letter no. 52042/आरटीआय/केस -127/2025(एम)/92 dated 24.03.2025 applicant was informed to pay the document charges. Further applicant filed First Appeal on the ground that response was not given within the time limit. Since PIO, WR has informed twice to the applicant to pay the requisite charges for documents which is as per provisions of RTI Act, therefore, the appellant is advised to pay the requisite charges for documents, as requested by PIO, WR vide letter dated 24.03.2025 in order to supply information. No further direction is required to be given to the PIO, WR.

3.2 **ORDER:**

With the above observations, the Appeal 18.04.2025 of Sh. **Shridhar Sadashiv Dhanawade** hereby stands disposed off.
