1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Sh. Jai Kumar Rai had submitted RTI application dated 18.03.2025 to PIO, WR regarding confirmation whether passenger, Kajal Shivhare was on board by Go First & Indigo flights from Nagpur Airport on 14.09.2022 .
- 2.2 The Appellant filed first Appeal dated 18.04.2025 before First Appellate Authority, RHQ, WR, Mumbai.
- 2.3 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

Confirmation whether passenger, Kajal Shivhare was on board by Go First & Indigo flights from Nagpur Airport on 14.09.2022 .

3.1 FINDINGS:

From the records produced it is seen that applicant vide RTI application dated 18.03.2025 has sought information regarding confirmation whether passenger, Kajal Shivhare was on board by Go First & Indigo flights from Nagpur Airport on 14.09.2022. The PIO, Nagpur Airport has transferred RTI application to MIHAN India Ltd. as the Nagpur Airport is handed over to MIHAN India Ltd. w.e.f. 07.08.2009.

Thereafter vide letter no. MIL/57-K/2025/66 dated 24/03/2025 provided information was provided to the applicant by MIHAN India Ltd.


Not satisfied with the reply provided by MIHAN India Ltd. the applicant has filed first appeal before First Appellate Authority, AAI, RHQ, WR.

In this regard it is to mention here that Nagpur Airport is now operated by MIHAN India Ltd., therefore information sought by the applicant is not available with AAI, Nagpur Airport. Further, in this case the information has been provided by MIHAN India Ltd., accordingly, the first appeal lies with that public authority. But since the Appellant has filed first Appeal with First Appellate Authority, AAI, WR, the first appeal need to be transferred to MIHAN India Ltd. for a decision.

In view of above, PIO, WR is directed to transfer first appeal to above concerned public authority.

3.2 ORDER:

With the above observations, the Appeal 17.04.2025 of Sh. Jai Kumar Rai hereby stands disposed off.
