### 1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

### 2.0 FACTS:

- 2.1 Sh. C. M. Pimple submitted RTI application dated 22.02.2025 to PIO, WR regarding 'Attested photocopy of agreement between MSF (Maharashtra Security Force) and MADC regarding deployment of MSF at Jalgaon Airport.1
- 2.2 PIO, WR vide e-mail dated 25.02.2025 transferred RTI application to PIO, Jalgaon Airport for providing information directly to the applicant.
- 2.3 The Appellant filed first Appeal dated 24.04.2025 before First Appellate Authority, RHQ, WR, Mumbai.
- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarized as under:

Brief of the RTI application filed by the appellant:

1. The applicant has sought information regarding Attested photocopy of agreement between MSF (Maharashtra Security Force) and MADC regarding deployment of MSF at Jalgaon Airport.
2. Which agency amongst AAI and MADC is responsible for providing office space, electricity and water facility to MSF at the Jalgaon Airport.
3. Currently who is providing office space, electricity and water facility to the MSF at Jalgaon airport and at what Rate (in rupees). Also Details of

Office space provided size and location.

4. The attested photocopy of bills of last 5 years send to MSF or MADC against providing the above-mentioned facilities to MSF at Jalgaon airport.

5. Provide attested copy of the rate at which AAI providing office space, electricity and water facility to other agencies working at Jalgaon airport like airlines and copy of last billing of all agencies.

6. State whether AAI provides stationary to the other agencies working at Jalgaon airport like Airlines, MSF, FTO.

7. Attested documents stating what stationary provided to MSF from last 2 years at Jalgaon airport.

8. Requires attested photocopy of any kind bills, reimbursement made/send by MSF Jalgaon airport to MADC Maharashtra from last 5 years to till date.

### 3.2 FINDINGS:


From the records produced it is seen that applicant has sought Attested photocopy of agreement between MSF (Maharashtra Security Force) and MADC regarding deployment of MSF at Jalgaon Airport.

In this regard PIO, Jalgaon Airport vide letter no. भाविप्रा/जलगाव/आरटीआई/2025 dated 10.03.2025 informed applicant that sought information is not available. The applicant has filed first appeal stating that provided, incomplete, misleading or false information.

In this regard it would be pertinent to mention here that a citizen has a 'Right To Information' under RTI Act. As such a citizen has a right to get only such information from a public authority which is held by it or which held under its control. Since the sought information is not available as informed by PIO, Jalgaon Airport to the applicant, therefore, as per Section 6(3) of RTI Act, PIO, Jalgaon Airport is directed to transfer RTI application to concerned public authority informing applicant about the transfer.

### 3.3 ORDER:

With the above observations, the Appeal dated 24.04.2025) of Sh. C. M. Pimple hereby stands disposed off.
