

1.0 PREAMBLE:

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Vasim Mamad Sandhisama had submitted RTI application seeking information regarding the reason for his removal from AMC work and process followed for the removal.
- 2.3 The Appellant filed 1st Appeal dated 12.05.2025 before First Appellate Authority, AAI, RHQ WR, Mumbai stating that 'No response within the time limit.'

3.0 FINDINGS & ORDER :

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :
Brief of the RTI application filed by the appellant:
 1. Notice issued for termination of services
 2. Any Investigation done before terminating
 3. Leave details for the year 2024-25
 4. Name of previous agency & other relevant information
 5. To enter into airport premises & meeting the staff.

3.2 FINDINGS:


With the records produced it is seen that applicant was deployed by AMC contractor under the AMC work at Bhuj Airport. The applicant has filed RTI request for seeking information regarding the reason for his removal from AMC work and process followed for the removal. In this regard PIO, Bhuj Airport vide letter no. भा.वि.प्रा./भुज/आरटीआई/2025/011/01-02 dated 09.05.2025 along with the ION dated 21.04.2025 has provided clear and specific information to the applicant concerned with Civil Engg. Deptt.

Further, In the above ION dated 21.04.2025 it is mentioned that information sought for entering in the airport premises and meeting the airport staff & other information may be provided by concerned deptt. Hence PIO, Bhuj Airport is directed to provide information to the applicant as per provisions of RTI Act.

- 3.3 The instructions contained in the above order may be complied within 15 days of receipt of this order.

3.3 ORDER:

With the above observations, the Appeal dated 12.05.2025 of Vasim Mamad Sandhisama hereby stands disposed off.
