1.0 PREAMBLE:

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Ms. Ashwini Akashe had submitted RTI application dated 09.04.2025 seeking information regarding Rules & regulations for constructions, Documents for NOC, Clearance & NOC for two buildings survey no. 52/1/85 and 52/1/105 etc.
- 2.3 The Appellant filed first Appeal dated 16.05.2025 before First Appellate Authority, AAI, RHQ, Mumbai.

3.0 FINDINGS & ORDER :

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

3.2 **FINDINGS:**


With the records produced it is observed that applicant vide RTI application no. AAIMU/R/E/24/00036 dated 06.03.2024 has sought information regarding Rules & regulations for constructions, Documents for NOC, Clearance & NOC for two buildings survey no. 52/1/85 and 52/1/105 at Pune, Permissible height building in Zone, Actions in case of non-issuance of NOC, Environmental and Aviation related restrictions, Clearances required for constructions.

In this regard it is seen that information regarding NOC for height clearance comes in the jurisdiction of Indian Airforce, therefore, informing applicant the RTI application was transferred under section 6(3) of RTI Act to Indian Airforce, Pune for providing information to the applicant. Accordingly, the above public authority is the First Appellate Authority for the first appeal dated 16.05.2025 and therefore PIO, WR is directed to transfer first appeal for decision in the matter. Also the applicant is advised to liaise with above public authority with respect to the appeal.

3.2 The instructions contained in the above order may be complied within 15 days of receipt of this order.

3.3 **ORDER:**


