1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Sh. Nand Kishor had submitted RTI application no. AAIMU/R/T/25/00053 dated 09.04.2025 to PIO, WR regarding Shift duties in CNS Deptt. At Rajkot Airport.
- 2.2 PIO, WR vide email dated 15.04.2025 transferred RTI application to PIO, Rajkot Airport to provide information directly to the applicant.
- 2.2 The Appellant filed first Appeal dated 06.06.2025 before First Appellate Authority, AAI, RHQ, Mumbai stating that "Refused access to information requested."
- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

The applicant has sought information regarding Shift duties in CNS Deptt. At Rajkot Airport.

1. Please provide details whether Sh. Parth Gandhecha Supdt.(Elex) has performed any shift duties as an equipment room/navaids shift duty officer from 10/09/2023 to 02/04/2025. If yes please provide following details:
- 1) Please furnish copy of relevant rule by which a non-executive has performed shift duties as individual shift duty officer.
 - 2) Who shall held responsible if any fault/error occur on these duties?
 - 3) Please provide details who has signed equipment room/ navaids facilities daily preventive schedules on these duties.
 - 4) Please provide details name of officer who has written log book of equipment room/ navaids facilities on these duties.
 - 5) Please provide name of the officer who has approved these duties.
2. Please provide details whether Sh. H K Bagthariya Sr.Sup.(EM) has performed any duty at Airports Authority of India, Civil Aerodrome, Rajkot-360006 (Gujarat) from 10/09/2023 to 02/04/2025. If yes please provide following details:

- 1) Please provide name of the officer who maintains records of duties performed by Sh. H K Bagthariya Sr.Sup.(EM) from 10/09/2023 to 02/04/2025 at Airports Authority of India, Civil Aerodrome, Rajkot-360006 (Gujarat).
- 2) Please provide name of the officer who has approved these duties performed by Sh. H K Bagthariya Sr.Sup.(EM) from 10/09/2023 to 02/04/2025 at Airports Authority of India, Civil Aerodrome, Rajkot-360006 (Gujarat).
- 3) Please provide name of the officer who has supervises these duties performed by Sh. H K Bagthariya Sr.Sup.(EM) from 10/09/2023 to 02/04/2025 at Airports Authority of India.

3.2 **FINDINGS:**

From the records produced it is seen that PIO, Rajkot Airport vide letter no. भा. वि. प्रा.रा. अं. ह./आरटीआई/एपीडी/2012-13 dated 13.06.2025 informed applicant that 'The information sought by the applicant may not be provided as under section 8 1 (j) of RTI Act.'

The applicant filed first appeal on the ground of Requested information is refusedby PIO, Rajkot Airport.


In this regard it is seen that applicant is seeking name of various officials performing duties in CNS deptt. At Rajkot Airport. However, while seeking such information the applicant has not established any larger public interest. It seems that the sought information has no connection to any public activity for disclosure of information.

However, with regard to copy of relevant rule by which a non-executive has performed shift duties as individual shift duty officer sought by the applicant, PIO, Rajkot Airport is directed to provide the same if available on record and if it is not available to inform the applicant.


- 3.3 The instructions contained in the above order may be complied within 15 days of receipt of this order.
