

1.0 PREAMBLE:

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Sh. Amit Mehta had submitted RTI application no. AAIMU/R/E/25/00102 dated 24.06.2025 seeking information regarding Action taken by AAI Gondia Airport against M/s. Nilesh Engineers.
- 2.2 PIO, Gondia Airport vide letter no. भाविप्रा/गोंदिया/एपीडी /आरटीआई-क्षेत्रीय मू./092025-26/1462-63 dated 30.06.2025 provided information to the applicant.
- 2.3 The Appellant filed first Appeal dated 02.07.2025 before First Appellate Authority, AAI, RHQ, Mumbai.

3.0 FINDINGS & ORDER :

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

Action taken by AAI Gondia Airport against M/s. Nilesh Engineers.

3.2 FINDINGS:

With the records produced it is observed that applicant has stated that AAI Gondia Airport has floated tender no. GEM/2024/B/4888419 On Gem PORTAL For Airport terminal Chair QTY 31. In this bid M/s. Nilesh Engineers had submitted false /forged documents . The applicant has sought information regarding Action taken by AAI Gondia Airport against M/s. Nilesh Engineers.


In this connection PIO, Gondia Airport vide letter no. भाविप्रा/गोंदिया/एपीडी /आरटीआई-क्षेत्रीय मु./092025-26/1462-63 dated 30.06.2025 informed application stating that ' The case is forwarded to Competent Authority for blacklisting M/s. Nilesh Engineers.

The applicant filed first appeal asking why the action is pending from AAI, RHQ, WR on the matter of blacklisting M/s. Nilesh Engineers.

In this regard it is seen that the applicant in his RTI application has sought information regarding action taken by Gondia Airport and vide above letter dated 30.06.2025 PIO, Gondia Airport has already informed the status/position to the applicant. Further, it is also observed that applicant has raised another queries / points in the appeal which is not admissible at appeal stage.

3.3 ORDER:

With the above observations, the Appeal dated 02.07. 2025 of Appellant hereby stands disposed off.
