1.0 PREAMBLE:

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Sh. Kapil Rathod had submitted RTI application dated 23.05.2025 seeking information regarding copy of height clearance NOC issued to school building in Nanded City during the year 2017.
- 2.2 The Appellant filed first Appeal dated 04.07.2025 before First Appellate Authority, AAI, RHQ, Mumbai.

3.0 FINDINGS & ORDER :

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Copy of height clearance NOC issued to school building in Nanded City during the year 2017.

3.2 **FINDINGS:**

With the records produced it is observed that applicant has sought copy of height clearance NOC issued to school building in Nanded City during the year 2017.

The PIO, Nagpur Airport vide letter no. **भाविप्रा/एनपी/एचआर/आरटीआई/2025/32335/36** dated 24.06.2025 informed applicant stating that 'No such information is available at this office.

In this regard it is seen that applicant has filed RTI application to Nagpur Airport for NOC issued by Nanded Airport during the year 2017. It is pertinent to mention here that from the year 2018 Nagpur Airport has started functioning in the capacity of issuance of NOC for Height Clearance. Therefore information sought by the applicant for the year 2017 is not available at Nagpur Airport.

However, PIO, Nagpur Airport is directed to forward RTI application to the concerned Deptt. for further necessary action keeping in view the provisions of RTI Act.

Also the IPO of Rs. 20/- may be returned to the applicant as no fee is required for filing the first appeal.

3.3 The instructions contained in the above order may be complied within 15 days of receipt of this order.

3.4 **ORDER:**

With the above observations, the Appeal dated 04.07. 2025 of Appellant hereby stands disposed off.
