**1.0 PREAMBLE**

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

**2.0 FACTS:**

- 2.1 Sh. K S Lakshminarasimhan had submitted RTI application dated 19.08.2024 to PIO, WR for seeking documents from his service book, APR File and from personal file.'
- 2.2 Since the sought information pertains to Juhu Airport, therefore RTI application was transferred to PIO, Juhu Airport.
- 2.3 The Appellant filed first Appeal dated 14.10.2024 before First Appellate Authority, AAI, RHQ WR, Mumbai.

**3.0 FINDINGS & ORDER :**

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

The applicant has sought his own documents from service book, APR file and personal file.

**3.2 FINDINGS:**

From the records produced it is seen that applicant has specified the list of various documents in the RTI application. Being the Deemed PIO & Custodian of information, the RTI application was transferred u/s 6(3) of RTI Act to PIO, Juhu Airport for providing information directly to the applicant. In this regard PIO, Juhu Airport vide letter no. भा. वि.प्रा./जुहू/आर.टी.आय./2024-25/17



Dated 25.09.2024 informed applicant stating that "Since the matter is in High Court and under litigation, documents cannot be provided due to High Court Order dated 12.08.2024."
