1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Sh. **Surendra** had submitted RTI application no. AAIMU/R/E/24/00154 dated 06.10.2024 to PIO, WR.
- 2.2 The Appellant filed first Appeal no. AAIMU/A/E/24/00044 dated 19.10.2024 before First Appellate Authority, AAI, RHQ WR, Mumbai.

3.0 FINDINGS & ORDER :

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

The applicant supplied electrical spares to AAI, Jabalpur Airport and requested to refund the amount due as per the statement.


3.2 FINDINGS:

The applicant in his RTI application stated that he had supplied electrical spares to AAI, Jabalpur Airport and requested to refund the amount due as per the statement. In this regard PIO, WR vide letter no. 52042/RTI/Case-435/24(M)/396 dated 09.10.2024 informed applicant that sought information is not as per RTI Act, hence the RTI application is returned herewith.

On going through the RTI application and appeal it is seen that applicant has not sought information as defined u/s 2 (f) of RTI Act. The applicant has made grievances rather seeking information under RTI Act, therefore said RTI application do not come under the ambit of RTI Act. Hence PIO, WR has rightly rejected RTI application.

3.3 ORDER:

With the above observations, the Appeal no. AAIMU/A/E/24/00044 dated 19.10.2024 of Sh. **Surendra** hereby stands disposed off.
