1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Sh. Mangal Laxman Rajput had submitted RTI application dated 25.08.2024 to PIO, Juhu Airport regarding 'Illegal Construction on the land bearing CTS no. 949
- 2.2 The Appellant filed first Appeal dated 21.10.2024 (Received on 22.10.2024) before First Appellate Authority, AAI, RHQ WR, Mumbai.

3.0 FINDINGS & ORDER :

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

Brief of the RTI application filed by the appellant:

The applicant has attached map issued to him by City survey office, Vile Parle West and sought information regarding two structures presently shown on the map as whether these structures are Airport structure or slumlord Mukesh Ramchandra . Any survey of these structures by AAI.

3.2 **FINDINGS:**

From the records produced it is seen that applicant Sh. Mangal Rajput had filed RTI application to PIO, Juhu Airport for seeking information regarding Unauthorized construction carried out by Mukesh Ramchandra Rajput and his family on the land of CTS no. 949 and the survey of two structures on CTS no. 949. Subsequently, the applicant filed first appeal on the ground of 'No information has been provided by PIO, Juhu Airport.'

In view of above PIO, Juhu Airport is directed to provide information to the applicant, if any, as per provisions of RTI Act.

3.3 The instructions contained in the above order may be complied within 15 days of receipt of this order.

3.4 **ORDER:**

With the above observations, the Appeal dated 21.10.2024 (received on 22.10.2024) of Sh. **Mangal Laxman Rajput** hereby stands disposed off.
