### **1.0 PREAMBLE**

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

### **2.0 FACTS:**

- 2.1 **Sh. Laxman Choudhary** had submitted RTI application dated 22.09.2024 to PIO, WR seeking information regarding 'Biometric Attendance system at Shirdi Airport.'
- 2.2 The Appellant filed first Appeal dated 28.10.2024 before First Appellate Authority, AAI, RHQ WR, Mumbai.

### **3.0 FINDINGS & ORDER :**

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

### 3.2 **FINDINGS:**


The applicant an employee of AAI has sought information regarding the status of Aadhar enabled Biometric Attendance system and copy of memorandum of RHQ, WR for the installation of Biometric Attendance System for AAI employees at Shirdi Airport.

The Deemed PIO & Custodian of information i.e. AGM (CNS), Shirdi Airport vide e-mail dated 03.10.2024 provided information to the applicant. The applicant filed first appeal on the ground that information provided is incomplete, misleading, false information. In this regard PIO, Shirdi Airport is directed to review the above mentioned reply provided to the applicant and provide specific information, if any, as per provisions of RTI Act.

3.3 The instructions contained in the above order may be complied within 15 days of receipt of this order.

### 3.4 **Order:**

With the above observations, the Appeal dated 28.10.2024 of Sh. Laxman Choudhary hereby stands disposed off.
