1.0 PREAMBLE

- 1.1 This Order is made under Section-19 of the Right to Information Act, 2005.
- 1.2 An appeal against this order lies with Central Information Commissioner, Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.
- 1.3 The Appeal can be filed within 90 days from the date on which this order should have been made or is actually received.

2.0 FACTS:

- 2.1 Smt. Rekhaben Parmar had submitted RTI application dated 01.05.2024 to PIO, Rajkot Airport seeking information about her husband working at Rajkot Airport.
- 2.2 The Appellant filed first Appeal dated 16.10.2024 (Received on 28.10.2024) before First Appellate Authority, AAI, RHQ WR, Mumbai.

3.0 FINDINGS & ORDER :

- 3.1 Having gone through the Appeal, the RTI application and the supply of information details, the case is summarised as under :

3.2 FINDINGS:

The applicant Smt. Rekhaben has sought 'Certified copies of all details/documents of Devkubhai Keshabhai Parmar (Ex-Army man) resident of Bamanbor (Navagam), Tehsil:Chotila, District: Surendranagar Who is serving as Security man at Hirasar Airport.' In this regard PIO, Rajkot Airport vide letter no. भा.वि.प्रा/रा.अं.ह./आरटीआई/एपीडी/2858-59 dated 08.08.2024 informed applicant that requested information may not be provided as per section 8 (1) (j) of RTI Act.

At outset it is seen that the applicant in her RTI application has not specified the details of sought documents. The word 'All Documents' is a wider term which needs to be interpreted while providing information. However, as per RTI Act PIO cannot interpret the information sought by the applicant. Further, it is also seen that applicant is seeking information pertaining to her husband which is a personal information. Therefore PIO, Rajkot Airport has rightly exempted information as per section 8 (1) (j) of RTI Act.

3.3 ORDER:

With the above observations, the Appeal dated 16.10.2024 (Received on 28.10.2024) of Smt. Rekhaben Parmar hereby stands disposed off.
